







Collaborative team led by School of Geography, with School of Computing, LIIHRH and CaHRU win Wellcome Data Science Ideathon on climate and health

A team from the University of Lincoln came first in the Climate and Health section of the Wellcome Data Science Ideathon which took place from 10-12 July at the Welcome Institute in London. This was a competition involving 24 academic teams and almost 100 researchers from institutions across the United Kindom supported to investigate the link between climate and health. The team, led by Dr Harriet Moore (right) also included Prof Edward Hanna (School of Geography), Dr John Atanbori (School of Computing), Prof Mark Gussy (IIIRH) and Prof Niro Siriwardena (CaHRU).

The téam are researching the link between methane and health (respiratory and mental health) emergencies building on work led by Dr Moore over the past two years. This addresses Wellcome's strategic priorities around mental health, infectious disease and climate and health and their wish to bring researchers from different disciplines together to tackle this important global challenge.

The conference theme of 'Informed and inclusive primary care' included oral presentations from the NIHR Applied Research Collaboration East Midlands REACH (Researching Emergency Ambulances in Care Homes) study and studies of performance of doctors in the UK MRCOP licensing examination for general practice.

There were two presentations from the team from the REACH study including two oral presentations on the first day of the conference, 'A qualitative study of ambulance personnel, care staff and service users' experiences and perceptions of emergency care in care homes' (Despina Laparidou) and 'Predictors of conveyance of care home residents to hospital by ambulance services for medical emergencies' (Niro Siliwardena).

On the second day followed three presentations including, Exploring perceptions of doctors in GP specialty training with specific learning difficulties undertaking clinical and work place-based assessments for GP licensing; interview study (Julie Pattinson) "Performance of doctors with specific learning difficulties in the UK GP licensing Applied Knowledge Test data interpretation questions' (Niro Siriwardena), and a poster on "Performance of doctors in the UK GP licensing Applied Knowledge Test for different question lengths' (Niro Siriwardena).

The conference and presentations were well attended and staff were pleased to present on behalf of the research teams involved.

He has worked on many economic evaluations alongside clinical trials and analysis of large datasets including individual patient data of trials and observational studies, routinely collected electronic health records

He was awarded an HTA trainee fellowship at the University of Aberdeen in 2007 after his PhD in geometric modelling at the University of Birmingham.

Tanja joined the Lincoln Clinical Trials Unit (LincCTU) in August 2023 as a Clinical Trials Manager.

She will be involved in the management of relational databases and the data management for clinical and other research trials within the LinCTU. Prior to joining, Tanja obtained theoretical and practical research experience across various fields within biology, including behavioural ecology, animal cognition and welfare by working across different research labs. After studying for her BSc in Behaviour at the University of Graz and her MSc in Neurobiology, behaviour and cognition at the University of Vienna in Austria, Tania obtained her PhD at the University of Lincoln in 2015. She investigated the causes and consequences of animal social network structure using fish as a model species, by developing custom Matlab code to track animals and analyse their social behaviour under different environmental conditions. After this she briefly worked as a research fellow for a small local agricultural company conducting R&D work as well as efficacy trials on plants and crops. In 2016 Tanja started a postdoctoral research fellowship funded by the NC3Rs, investigating automated predictive welfare assessments in groups of fish. During this time, she gained more experience with coding in Matlab, Python and R for data collection and statistical analysis. She is excited to join the LinCTU team, working on a variety of projects and collaborating with internal and external researchers



CaHRU presents two papers at the XX World Congress of Sociology in Melbourne, Australia, 25 June – 01 July 2023

Dr Gupteswar Patel, a member of the CaHRU team, presented two papers from the NIHR-funded Community First Responder project at the XX World Congress of Sociology in Melbourne, Australia, from 25 June to 01 July 2023.

his quadrennial conference brought together academicians, experts, and researchers from around the world to discuss the topic of "Resurgent Authoritarianism: Sociology of New Entanglements in Religions, Politics, and Economics." In addition to disseminating the project's findings, Dr Patel's presentations reinforced the symbiotic relationship between sociology and health

Patel's presentations reinforced the symbiotic relationship between sociology and health disciplines. Dr Patel presented two papers at the conference that illustrated crucial aspects of power dynamics in Community first Responder (CFR) provisions in conjunction with sociological factors. These papers explored the power relationships between CFRs, ambulance clinicians, and the

ambulance services as state institutions, demonstrating the complexities of power dynamics and their implications for the delivery of prehospital care. These investigations also contributed to a greater understanding of the complexities of governance and emphasised the importance of sociological considerations in CFR provisions.

Paper I, Power Dynamics in Out-of-Hospital Emergency Care: The Community First Responder – Ambulance Clinician Relationship in the United Kingdom.[GP] Sub-theme: Oppressors or Saviours? The Role of Professions in a Changing World This oral presentation investigated the relationships between CRFs and ambulance clinicians in out-of-hospital emergency settings. This paper examined the role of professional power in establishing a hierarchy within the division of labour in out-of-hospital contexts where both volunteer CFRs and professional ambulance clinicians attended to patients and delivered prehospital care.

Paper 2: Role of Community First Responders during the Pandemic in England; An Understanding of Field and Power Dynamics[GP1]

Sub-theme: COVID-19 Pandemic and Global Health Workforce Policies and Governance: Challenges and Issues at the Forefront.

This paper examined how ambulance services as state institutions modify the scope of practice for CFRs while protecting institutional interests amidst changing health system priorities during the Covid-19 pandemic. It examines the dynamics of decision-making, how health institutions adapt and respond to the evolving challenges posed by the pandemic, as well as the immilications for CFRs.

The XX World Congress of Sociology, held in Melbourne, Australia, provided an interdisciplinary forum to highlight the research contributions to Health Sociology.

Despine Laparidou, Research Assistant and part-time PhB student at CarRIV, recently attended the 18th European Congress of Psychology (ECP) at the Brighton Centre in Brighton (3-6 July 2023) and presented the findings of one of her PhD studies, called "The Stressor-Distress Relationship within Informal Carers of People with Dementia: Exploring the Role of Potential Cognitive Mediators and Moderators".

This year's theme for the conference was "Psychology, Uniting communities for a sustainable world" and the scientific programme included a combination of keynotes, 3-minute and 7-minute oral presentations, workshops, and posters. There were various thematic streams, including, but not limited to, Climate change and sustainability, Clinical psychology; Community psychology, Political psychology, Forensic psychology, Political psychology and demogracy and Psychological

One other conference theme was Geropsychology, Despina's 3-minute Thesis presentation discussed the findings of one of her studies, on online questionnalie study, which explores the relationship between stressors (specifically the physical, memory and behavioural problems of people living with demental) and informal carer distress, looking at cognitive factors that mediate or moderate this relationship and especially the carers' intrusive thoughts and cognitive coping strategies.

The pursuit of knowledge that began years ago with passion and dedication has finally achieved another milestone. I am thrilled to share the completion of my PhD from the University of Newcastle. Australia

The culmination of my PhD voyage was a defining moment characterised by pride, pleasure, and relief upon receiving my hard-earned PhD. The overwhelming sense of accomplishment was the result of years of hard work and commitment being recognised. The ceremony held in the Great Hall on the Callaghan campus of the University of Newcostle served as a visceral reminder of the magnitude of this accomplishment and becoming the first doctorate in my family.
